

# Tech Center Etiquette

The Tulalip Resort Casino wishes to provide equitable Tech Center use to all registered hotel guests. To better assist us in doing so, please observe the following computer courtesies:

- Tech Center use is for registered guests, or meeting / event attendees ONLY.
- Please obtain a computer access code card from Hotel Reception or Concierge. You will be asked to verify identification; and hotel registration (or attendee status) is required for authorized use.
- There are time limits for Tech Center use. Please reference the access code card or ask staff about this limitation when obtaining your access code card.
- Any person accessing pornographic, obscene, or inappropriate materials WILL BE REFUSED SERVICE at the Tulalip Resort Casino and subject to arrest and / or criminal prosecution.
- Using the Tech Center to engage in illegal or illicit activity is strictly forbidden. Persons doing so WILL BE REFUSED SERVICE at the Tulalip Resort Casino and subject to arrest and / or criminal prosecution.
- Refrain from downloading and/or installing software programs on the Tech Center computers. Doing so may result in the loss of Tech Center privileges.
- The Tech Center is electronically monitored 24 hours a day, 7 days a week, utilizing video and computer surveillance.
- If no computers are available, check with Hotel Reception or Concierge, or make a reservation for when a computer is available.
- Save your work on a USB format drive. You cannot save on the computer hard (C:) drive. USB Drives are available for purchase in our gift shop.
- Computer work stations are designed for easy stand up use. Please do not move furniture or block the aisle.
- One Computer work station is designed to accommodate the needs of ADA accessibility guests. Please allow for this specific use when needed by others.
- The ADA accessible workstation can accommodate the needs of younger guests as well. Parents, please supervise the computer use by minors.
- Please limit your printing to items of need only. Recycle paper appropriately, dispose of waste, and leave enough supplies for guests that follow after you.

# Tech Center Acceptable Use Policy

**Internet Access:** To assist users, Tulalip Resort Casino, has selected specific links, favorites and homepages for the Tech Center from the vast resources available on the Internet. Public access to the Internet is not limited to these links. The quality, accuracy and timeliness of information on the Internet varies from site to site, and sites may be controversial or of a mature nature. The Tulalip Resort Casino does not monitor, has no control over, and does not accept responsibility for material in other sources on the Internet. At their own discretion, Tech Center users access the Internet and are fully responsible for the results of their searches.

**Responsibilities of Computer Users:** The Tulalip Resort Casino requires computer users to respect the rights and sensibilities of all property guests. Some Internet sites are inappropriate for viewing in a public setting. Users should refrain from the use of Internet sounds and visuals that may disrupt the ability of other guests to enjoy or use the resort casino and its amenities. Tulalip Resort Casino team members and Tulalip Tribes Law Enforcement reserve the right to end internet sessions when sexually explicit or pornographic materials are displayed. Likewise, the similar reserved rights apply to materials that would in most normal circumstance be deemed obscene, or inappropriate in a public setting. The reserved right to end Internet sessions also applies to activity that is, or can be construed as, illicit or illegal. (See also Illegal and Unacceptable Uses).

**Internet Safety:** The Tulalip Tribes are partners with parents in guiding children to safe and appropriate use of the Internet. In compliance with requirements of the Children's Internet Protection Act (CIPA) and the Neighborhood Children's Internet Protection Act (NCIPA), the Tulalip Resort Casino may filter all Internet computers. Adult patrons age 18 years and older may elect to disable the filter for unrestricted Internet access for any lawful purpose that meets Tech Center guidelines. Parents and guardians are responsible for supervising their children's Internet sessions and for letting their children know if there are materials children should not use or view. Parents and guardians are directed to the "[Child Safety on the Information Highway](#)" produced by the National Center for Missing and Exploited Children and Inter-active Service Organizations for assistance on protecting their children.

**Copyright:** U.S. Copyright law (Title 17, U.S.C.) Prohibits the unauthorized reproduction or distribution of copyrighted materials, except as permitted by principles of fair use. Users may not copy or distribute electronic materials (including electronic mail, text, images, programs or data) without the explicit permission of the copyright holder. Any responsibility for any consequences of copyright infringement lies with the users; the Tulalip Tribes expressly disclaims any liability or responsibility resulting from such use.

**Software/Hardware:** Tech Center software is copyrighted and may not be reproduced. (See also Copyright). Users may not load their own or any other software on Tech Center equipment. Users are not permitted to store any software or other data on the hard drives of the Tech Center computers or alter the programs currently installed on the systems. Anyone tampering with any Tech Center hardware or software will be denied access to its computers in the future, and may also be refused service at Tulalip Resort Casino or any of its ancillary entities.

**Disclaimer:** Users access the Tech Center computer hardware, software and documentation at their own risk. The Tulalip Resort Casino is not responsible for equipment malfunction, loss of data, any damages to the user's disks, data etc. or electronic transactions of any type which are related to the public use of Tech Center computer resources.

**Illegal and Unacceptable Uses:** People may use the Tech Center computers only for legal purposes. Examples of unacceptable uses include but are not limited to the following:

- Display of sexually explicit or pornographic materials;
- Harassment of other users or violation of their privacy;
- Libeling, slandering or maliciously offending other users;
- Violation of copyright laws or software licensing agreements;
- Attempting to crash, degrade performance or gain unauthorized access to the Tulalip Tribes, or to other computer systems and networks;
- Damaging equipment, software or data belonging to the Tulalip Tribes or other users.

Violations may result in the loss of Internet and/or guest privileges. Illegal use of the computers also may be subject to prosecution by local, state or federal authorities with monetary penalties and / or incarceration.

**Compliance:** Failure to comply with this policy, Tech Center Etiquette, or with Tulalip Resort Casino staff directions may result in restriction or termination of guest privileges, and/or result in prosecution under local, state or federal laws with monetary penalties and / or incarceration.

**ADA Accessibility:** One workstation within the Tech Center enables persons with ADA accessibility needs to access the internet. If additional assistance is required or accommodation by others is not made, please see a Tulalip Resort Casino team member for assistance.

**Privacy Policy:** The Tulalip Resort Casino is committed to protecting the privacy of its guests and Tech Center users. We believe strongly that users deserve to have their personal privacy protected while using the Internet. While the Tech Center is monitored by both computer and video surveillance, this data is not used for any purpose other than to prevent or prosecute illegal or illicit activity. Access to this data is strictly controlled and is shared only under applicable law.
