Tulalip Resort Casino (TRC) offers free RV parking to My Tulalip Card Members who utilize our gaming facilities during their stay. The following RV parking rules and guidelines have been established in order to create a safe and enjoyable experience for guests. If you have any questions, please feel free to ask our security or other casino personnel. R.V. parking is on a first-come first served basis. No reservations accepted.

TRC assumes no responsibility or liability for the safety and security of guests/visitors and their personal property. TRC is not liable for any damage to or loss of personal possessions, vehicles, equipment, or property; or injuries to any occupants or visitors while at our park. TRC reserves the right to seek reimbursement for harm or destruction of property. Guests may be asked to leave for failure to comply with RV parking rules, or any other activity deemed not in the best interest of TRC.

It is impossible to have rules and regulations covering every contingency and situation and we reserve the right to update these rules and regulations at any time without prior notice. Guests have the responsibility to inquire into any policy that may not be published in these rules and regulations. Failure to do so is not grounds for the granting of an exception.

Local law enforcement and security personnel actively patrol the RV parking area. Those who violate WA State criminal law, federal law, or tribal law shall be subject to criminal prosecution. Possession or use of illegal substances (drugs) is strictly prohibited and will not be tolerated.

TRC RV parking rules and Regulations:

RV rules and regulations include but are not limited to the following:

- 1. Maximum duration of stay is 3 days within a 14 day period.
- 2. All vehicles, RV, trailer, or boats must have a current License plate and tabs; and must be in good and clean condition. Trip Permits are not accepted.
- 3. RV, trailers, or boats must not be left unattended for an extended amount of time.
- 4. No vehicle maintenance may be performed onsite.
- 5. One (1) vehicle, other than the RV, per space is allowed.
- 6. Awnings are allowed only for one space. Pop-ups are allowed, tents are not allowed.
- 7. Wood fires are not permitted at any time, however gas and charcoal grills are allowed.
- 8. No excessive storage allowed. Personal items outside the RV must be kept tidy and within your assigned space at all times.
- 9. Trash will not be left sitting outside. Please dispose of trash properly in the containers provided.
- 10. All RV's must be self-contained. Dumping wastewater (grey water) is not permitted. Dumping services are not available.
- 11. Using TRC water and power sources is not allowed.
- 12. TRC reserves the right to limit number, size and type of pets. All animals are subject to Tulalip Tribal Code Chapter 3.65 (see www.codepublishing.com/wa/tulalip
 - a. No vicious or aggressive animals are allowed.
 - b. No excessively barking dogs.

- c. Pets must be housed inside your RV unit, and must be kept on a leash not longer than 6 feet in length at any time they are outside the RV unit.
- d. Please clean up immediately after your pet by discarding solid bio waste properly.
- 13. Alcoholic beverages are only permitted inside the RV. Glass containers are not allowed outside. Illegal drugs of any kind are not permitted.
- 14. Quiet hours are from 10:00pm-8:00am daily. Please be considerate of your neighbors at all times. No loud music or unruly conduct. Generators are to remain off during quiet hours.
- 15. Unruly conduct, loud, obnoxious or lewd behavior, public intoxication and profanity will result in your removal from the TRC property.
- 16. Brandishing, open display, or use of firearms of any type, including BB guns, air guns, and/or paintball guns is not allowed on TRC property.
- 17. Any damage or destruction of TRC property will be charged criminally and the guest will be required to leave property.
- 18. Fireworks are not permitted on TRC property including the Fourth of July and New Year's.
- 19. TRC reserves the right to refuse services to anyone for any reason as well as the right to add to or amend RV Lot policies at any time. Any refusal to follow policies or laws may result in guests being asked to leave.
- 20. TRC reserves the right to review gaming play and guests may be asked to leave if they are not actively gaming.
